A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2022-20-02 OF THE MUNICIPALITY OF MANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 2022-20-02 of the Municipality of Manay, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 01, involving an appropriation of **Thirty-Seven Million Eight Hundred Sixty-Nine Thousand Nine Hundred Four Pesos & 67/100 (P37,869,904.67)**, was submitted to this Sanggunian for review on October 18, 2022, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Shella Marie S. Go, Stephen Paul L. Uy, Harold A. Montes, Rotchie M. Ravelo, Daud V. Linsag, and Eleuterio C. Manaytay, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-20-02 of the Municipality of Manay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- a. Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2022 Supplemental Annual Investment Program (SAIP)/Development Plan pursuant to Sections 287 and 305(i) of RA 7160, DILG MC No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF JMC No. 1, s. 2016, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. It is understood that the PPAS in the Supplemental AIP in this budget were likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in a resolution form, a copy of the same shall be attached as supporting document of this budget;
- b. Utilization of Confidential Fund shall be in accordance with DBM-DILG-DND-GCG-COA Joint Circular No. 2015-01, dated January 8, 2015. Likewise, PPAs under the Peace and Order fund shall be in accordance with DILG MC No. 2015-128, dated November 2, 2015, and other relevant policies and budgeting accounting and auditing rules and regulations;
- c. The lump sum appropriations in Special Purpose Appropriation / Other MOOE / Capital Outlay, etc. shall be subject to Sections 305(b) and 335 of RA 7160; RA 9184 and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures. that the LGU shall adapt the measure of not filling-up vacant funded positions except for mandatory one, and no creation of positions, in order to reduce the aforesaid excess of 6% in the amount equivalent to that which is within the exact 45% limitation, pursuant to DBM LBC No. 98 dated, October 14, 2011; and Section 325(a) of RA 7160;

RESOLVED FURTHER, to inform the Municipality of Manay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

MOREOVER, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016 in relation to Sections 56(a) and 327 of RA 7160, and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "*Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review.*"

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Manay, Davao Oriental, through the Municipal Mayor.


