WHEREAS, Municipal Ordinance No. 15-02-11-2022, entitled: *AN ORDINANCE FOR THE IMPOSITION OF REGULATORY FEES AND OTHER SERVICE CHARGES OF THE LOCAL GOVERNMENT UNIT OF BOSTON, DAVAO ORIENTAL*;

WHEREAS, the Sangguniang Bayan, pursuant to Section 187 of RA 7160, has conducted a public hearing on September 9, 2022, before the enactment of the subject municipal ordinances on November 7, 2022;

WHEREAS, Section 132 of the Local Government Code of 1991 provides for the power of the LGU concerned to impose a tax, fee or charge to generate revenue through an appropriate ordinance;

WHEREAS, Section 56 and 468(a)(1)(i) of the same Code provides that the Sangguniang Panlalawigan shall examine the forwarded approved ordinance of the municipality to determine whether such is beyond the power of the sangguniang bayan;

WHEREAS, the Local Treasurers may be required by the sanggunian to act as resource person during the review of the submitted local revenue measures;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Shella Marie S. Go, Stephen Paul L. Uy, Harold A. Montes, Rotchie M. Ravelo, Daud V. Linsag, and Eleuterio C. Manaytay, it was
