**WHEREAS**, Appropriation Ordinance No. 03-2022 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 3, involving an appropriation of **Twenty-Four Million One Hundred Forty-Five Thousand One Hundred Forty-Two Pesos & 90/100 (P24,145,142.90)**, was submitted to this Sanggunian for review on December 1, 2022, pursuant to the provisions of Republic Act No. 7160;

**RESOLVED**, to declare Appropriation Ordinance No. 03-2022 of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. The lump sum appropriations in Special Purpose Appropriations/Other MOOE/Capital Outlay, etc. shall be subject to Sections 305(b) and 335 of RA 7160; RA 9184 (Government Procurement Reform Act) and its Revised IRR; and other existing pertinent laws, rules and regulations imposing restraints on government expenditures;
2. Utilization of the LDRRM Fund shall conform to RA 10121 and its IRR pursuant to NDRRMC-DBM-DILG JMC No. 2013-1, dated March 25, 2013, and other related issuances;
3. The grant of Productivity Enhancement Incentive (PEI) shall be in accordance with DBM BC No. 2017-4;

**RESOLVED FURTHER**, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.




