WHEREAS, Appropriation Ordinance No. 05-2022 of the Municipality of Cateel, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 04, involving an appropriation of **Three Million Five Hundred Twenty Thousand Pesos (P3,520,000.00)**, was submitted to this Sanggunian for review on January 5, 2023, and the same was docketed as Communication No. 17-257-2023;

WHEREAS, Appropriation Ordinance No. 2022-06 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2022 Supplemental Budget No. 05, involving an appropriation of **Five Million Nine Hundred Fifty-Eight Thousand Seven Hundred Fifteen Pesos & 90/100 (P5,958,715.90)**, was submitted to this Sanggunian

for review on January 6, 2023, and the same was docketed as Communication No. 17-260-2023;

WHEREAS, Appropriation Ordinance No. 07-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2022 Supplemental Budget No. 07, involving an appropriation of **Four Million Four Hundred Thirty-Two Thousand One Hundred Eighty-Four Pesos & 54/100 (P4,432,184.54)**, was submitted to this Sanggunian for review on January 10, 2023, and the same was docketed as Communication No. 17-263-2023;

WHEREAS, Appropriation Ordinance No. 08-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2022 Supplemental Budget No. 08, involving an appropriation of **Two Million Three Hundred Thirty-Seven Thousand Fifty-Six Pesos & 48/100 (P2,337,056.48)**, was submitted to this Sanggunian for review on January 10, 2023, and the same was docketed as Communication No. 17-264-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on April 6 and 10, 2023, respectively;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Shella Marie S. Go, Harold A. Montes, Daud V. Linsag, Stephen Paul L. Uy, Ronald T. Lara, Jr., Anna Cheryl N. Castro, and Eleuterio C. Manaytay, it was
