A RESOLUTION INFORMING THE OFFICE OF THE OMBUDSMAN FOR MINDANAO, THROUGH ITS DEPUTY OMBUDSMAN, ATTY. ANDERSON A. LO, RELATIVE TO THE FIRST INDORSEMENT, DATED FEBRUARY 24, 2022, WITH REFERENCE CODE IC-OM-20-0533, THAT THIS SANGGUNIANG PANLALAWIGAN CANNOT ASSUME OR EXERCISE JURISDICTION FOR LACK OF VERIFIED COMPLAINT FROM MR. SERGS P. IGNACIO AGAINST FORMER MUNICIPAL MAYOR, HONORABLE ARTURO C. MONDAY AND MUNICIPAL TREASURER, MS. NORMA B. MORALES, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, CONSIDERING THAT THE SAME, BEING PART OF THE PROCEDURAL REQUIREMENTS MANDATED UNDER SECTION 61 OF RA 7160, WAS NOT FORMALLY RECEIVED BY THIS SANGGUNIANG PANLALAWIGAN.

WHEREAS, upon careful scrutiny of the records relative to the First Indorsement with Reference Code IC-OM-20-0533, more specifically the Verified Complaint from Mr. Sergs P. Ignacio addressed to this Sangguniang Panlalawigan, the same has not been received by this Office;

WHEREAS, in connection with the aforementioned subject matter, this August Body has acted thereon through SP Resolution No. 17-165-10-2022, dated October 12, 2022, with the request for Mr. Sergs P. Ignacio to provide a copy of the Ombudsman's Endorsement relative to his case;

WHEREAS, in order to take jurisdiction on the matter, Mr. Sergs P. Ignacio is likewise requested to provide the Sangguniang Panlalawigan a copy of his Verified Complaint, for appropriate action of this Honorable August Body, as mandated under Section 61 of RA 7160;


