AMENDING EXECUTIVE ORDER NO. 9, SERIES OF 2022, BY DESIGNATING THE HEAD OF THE PROVINCIAL GENERAL SERVICES OFFICE AS REGULAR MEMBER OF THE BIDS AND AWARDS COMMITTEE OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL IN LIEU OF THE NOW RETIRED PROVINCIAL LEGAL OFFICER

WHEREAS, the change of leadership in the Province of Davao Oriental last June 30, 2022 necessitated the issuance of Executive Order (EO) No. 9, Series of 2022, dated August 10, 2022, through which the undersigned, in her capacity as the new Head of the Procuring Entity (HOPE), directed the reconstitution of the Bids and Awards Committee (BAC) of the Provincial Government;

WHEREAS, by virtue thereof, the Department Head of the Provincial Legal Office (PLO) was designated as regular BAC member and as Chairman of the said Committee;

WHEREAS, the Head of the PLO officially retired from government service effective January 8, 2023;

WHEREAS, Section 11.2.6, Rule V of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act) provides, among others, that the members of the BAC shall have a fixed term of one (1) year reckoned from the date of designation, renewable at the discretion of the Head of the Procuring Entity HoPE), and that in case of resignation, retirement, separation, transfer, re-assignment, removal, or death of the original designated regular member, the replacement shall serve only for the unexpired term;

WHEREAS, due to the retirement of the PLO Head, there is a need to designate a replacement who shall serve his unexpired term as regular BAC member, and also the Chairman of the Committee;

NOW, THEREFORE, I, CORAZON N. MALANYAON, Governor of the Province of Davao Oriental, by virtue of the powers vested in me by law, do hereby designate **MR. MARIO L. GENTILES, Provincial Government Department Head (PGDH) of the Provincial General Services Office (PGSO) as regular member and Chairman of the Bids and Awards Committee (BAC).**

SECTION 1. Executive Order No. 9, Series of 2022 shall now read as follow:

SECTION 2. Term as Regular BAC Member and BAC Chairman. – Unless sooner removed for cause, the designation of Mr. Mario L. Gentiles as Regular BAC Member and BAC Chairman shall commence effective upon receipt of this Order and shall expire on August 15, 2023.

SECTION 3. Repealing Clause. – Previous issuances, orders, memoranda, or any part(s) thereof that are inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION 4. Separability Clause. – If any provision or part hereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

SECTION 6. Effectivity. – This Executive Order shall take effect immediately.
