



EXECUTIVE ORDER NO. 4-A

**RECONSTITUTION OF THE LOCAL SCHOOL BOARD (LSB) OF THE PROVINCIAL
GOVERNMENT OF DAVAO ORIENTAL**

WHEREAS, Republic Act No. 7160, otherwise known as the local Government Code of 1991, mandated the creation of the Local School Board in every provincial, city or municipality;

WHEREAS, the Provincial Local School Board shall be composed of the Governor and the Division Superintendent of School as co-chairmen; the chairman of the Education Committee of the Sangguniang Panlalawigan, the Provincial Treasurer, the representative of the Pederasyon ng mga Sangguniang Kabataan in the Sangguniang Panlalawigan, the duly elected representative of the Teacher's Organization, and the duly elected representative of the Non-Academic Personnel of public schools in the province, as members;

NOW, THEREFORE, I, CORAZON T. NUÑEZ-MALANYAON, Provincial Governor of Davao Oriental, by virtue of the powers vested in me by law pursuant to Article 184 of the Rules and Regulations Implementing RA 7160, do hereby order the reconstitution of the Local School Board of the Provincial Government of Davao Oriental with the following composition and functions:

Foregoing representations from the CSOs are on hold over capacity from the previous LSB, to avoid hiatus in the private sector representations, provided, that said representations may be updated when the selection process as prescribed by DILG MC No. 2016-97 shall have been undertaken.

Section 2 - Functions of the LSB

The Provincial Local School Board shall:

1. Determine, in accordance with the criteria set by the Department of education (DepEd), the annual supplementary budgetary needs for the operation and maintenance of public schools within the province and the supplementary local cost of meetings, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the especial levy on real property constituting the Special Education Fund and such other sources of revenue in the Local Government Code and other laws or ordinances may provide;
2. Authorize the Provincial Treasurer to disburse funds from the Special Education Fund pursuant to the budget prepared in accordance with applicable existing rules and regulations.
3. Serve as an advisory committee to the sanggunian concerned on education matters such as, but not limited to, the necessity for and the uses of local appropriations for education purposes; and
4. Recommend changes in the names of public schools within the territorial jurisdiction of the LGU for enactment by the sanggunian concerned.

Section 4 - Function of the LSB Secretariat

The Secretariat shall be responsible for providing technical support and documentation, preparation of reports and such other assistance as maybe required in the discharge of its functions.

Section 5 - Schedule of Meetings

The Provincial Local School Board shall meet every second Thursday of every month or as often as necessary when situation demands.

Section 6 - Funding

Funds for implementation of various programs/projects/activities, training expenses, and per diems to all regular members of the board, capability building and other administrative costs shall be sourced out from the Special Education Fund (SEF) and other sources, if any;

Section 7 - Repealing Clause

All Executive Orders, rules and regulations or parts thereof, which are in consistent with any provision of this Executive Order, are hereby repealed, amended, or modified accordingly.

Section 8 - Effectivity

This Executive Order shall take effect immediately.
