AN ORDINANCE CREATING ONE (1) POSITION OF PROVINCIAL GOVERNMENT ASSISTANT DEPARTMENT HEAD (LEGAL OFFICER V) UNDER THE PROVINCIAL LEGAL OFFICE, THIS PROVINCE.

WHEREAS, the Local Chief Executive has requested the Sangguniang Panlalawigan to pass an ordinance creating the abovementioned position;

WHEREAS, the creation of the said position is essential to significantly improve the effectiveness and efficiency in the delivery of legal services provincewide;

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that: *“Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.”*;

Be it ordained by the 17th Sangguniang Panlalawigan of Davao Oriental, in session duly assembled that:

SECTION 1. CREATION OF POSITION. The Creation of the position of Provincial Government Asssitant Department Head (Legal Officer V), SG 24, under the Provincial Legal Office, is hereby approved. Below are its minimum Qualification Standards (QS):

- Education** : Bachelor of Laws
Experience : 2 years of relevant experience involving management and supervision
Training : 8 hours of relevant training
Eligibility : RA 1080 (Philippine Bar Examination)

SECTION 2. SALARY AND COMPENSATION. The appropriation for its corresponding salaries, allowances, other emoluments, and benefits is already provided in the FY 2023 Annual Budget amounting to P1,602,048.00.

SECTION 3. IMPLEMENTATION. The implementation and execution of this Ordinance shall be subject to the existing and applicable Civil Service Laws, Rules and Regulations and shall be in accordance with relevant budget circulars of the Department of Budget and Management and other pertinent laws thereof.

SECTION 4. REPEALING CLAUSE. All existing measures with a provision or provisions which are inconsistent with this ordinance, the same are hereby amended or repealed accordingly.

SECTION 5. SEPARABILITY CLAUSE. Should any provision of this Ordinance is found invalid and declared unconstitutional, the rest of the provisions not otherwise affected shall remain effective and enforceable.

SECTION 13. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval hereof.
