MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE COCONUT AUTHORITY (PCA), REPRESENTED BY ITS ADMINISTRATOR, MR. BERNIE F. CRUZ, RELATIVE TO THE IMPLEMENTATION OF THE SEED FARM DEVELOPMENT PROJECT (SFDP) WITH A LAND AREA OF 5.0 HECTARES SEED FARM TO SERVE THE NEEDS OF THE COCONUT FARMERS IN THE PROVINCE.


