MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE COCONUT AUTHORITY (PCA), REPRESENTED BY ITS ADMINISTRATOR, MR. BERNIE F. CRUZ, RELATIVE TO THE ESTABLISHMENT OF THE COMMUNAL NURSERY AS A PROJECT COMPONENT OF THE COCONUT HYBRIDIZATION PROGRAM UNDER THE COCONUT FARMERS AND INDUSTRY DEVELOPMENT PLAN IN THE PROVINCE.


