A RESOLUTION REQUESTING THE HONORABLE MANUEL M. BONOAN, SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, THROUGH DPWH-XI REGIONAL DIRECTOR, REY PETER B. GILLE; AND 1ST AND 2ND DPWH DISTRICT ENGINEERS OF THE PROVINCE OF DAVAO ORIENTAL, ENGRS. JANE D. CAINGHOG AND CIRILO M. LASACA, RESPECTIVELY, FOR THE CONSTRUCTION OF AN OVERPASS/FOOTBRIDGE INFRONT OF SCHOOLS WITH PRIORITY TO THOSE LOCATED ALONG THE NATIONAL HIGHWAYS OF THIS PROVINCE.

WHEREAS, it is imperative for the Local Government Unit to promote the general welfare of its constituents, ensure their safety and provide services and facilities intended for their needs, pursuant to Section 16 and 17 of the Local Government Code, respectively;

WHEREAS, as majority of daily business operations and face-to-face classes in the Province of Davao Oriental resumes in full capacity, pedestrians and vehicles alike contribute to the increase in traffic, not just along the national highways, but most

especially in areas that has narrow lanes, where schools and business establishments are located;

WHEREAS, the increase in traffic also poses the danger of vehicular accidents of students crossing the streets within the school zones, without adults or traffic enforcers to accompany/guide them at the crosswalks, especially in areas that do not have alternative routes, having only a one-way street, and roadsides being used as parking zones, thereby restricting pedestrians' visibility;

WHEREAS, in order to prevent possible accidents as well as to reduce traffic congestion of both pedestrians and vehicles, the Provincial Government sees the need to construct an overpass / footbridge in front of the schools where the pedestrian infrastructure is essential;

WHEREAS, a footbridge / overpass in front of the schools will not only benefit the children, but also to the community in those areas, making it easier for them to walk safely, without worrying the risks of vehicular accidents;

WHEREAS, the Department of Public Works and Highways functions as the engineering and construction arm of the Government tasked to continuously develop its technology for the purpose of ensuring the safety of all infrastructure facilities and securing for all public works and highways the highest efficiency and quality in construction;

WHEREAS, the assistance from the National Government for this particular pedestrian infrastructure project is vital considering that the Provincial Government has also limited funds for the implementation of other equal priority programs, projects, and activities;

WHEREFORE, on motion of SP Member Joselito B. Villademoso, duly and jointly seconded by SP Members Shella Marie S. Go, Daud V. Linsag, Stephen Paul L. Uy, Ronald T. Lara, Jr., and Harold A. Montes, it was


