WHEREAS, Appropriation Ordinance No. 2022-20-02 of the Municipality of Manay, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an appropriation of **Two Hundred Forty-Six Million Three Hundred Forty-Four Thousand Three Hundred Seventy-Two Pesos (P246,344,372.00)**, was submitted to this Sanggunian for review on January 11, 2023, and the same was docketed as Communication No. 17-272-2023;

WHEREAS, Appropriation Ordinance Nos. 09-17-2022 and 10-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its FY 2023 General Fund Annual

Budget and Annual Budget for Public Utilities & Economic Enterprise, involving an appropriation of One Hundred Seventy-Nine Million Four Hundred Twenty-Two Thousand Seven Hundred Seventy-Two Pesos (P179,422,772.00) and Six Million Six Hundred Eighty-Two Thousand Twelve Pesos (P6,682,012.00), respectively, were submitted to the Sanggunian for review on January 11, 2023, and the same were docketed as Communication No. 17-274-2023;

WHEREAS, Appropriation Ordinance No. 01, series of 2022, of the Municipality of Tarragona, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 01, involving an appropriation of Eight Million Three Hundred Ninety-Two Thousand Eighty-Eight Pesos & 19/100 (P8,392,088.19), was submitted to this Sanggunian for review on January 23, 2023, and the same was docketed as Communication No. 17-297-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on April 11 and 21, 2023, respectively;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;


