MALANYAON, DOCKETED AS COMMUNICATION NO. 17-278-2023, FOR HER LEGAL OPINION ON WHETHER THE PRESENT LOCAL CHIEF EXECUTIVE MUST FIRST BE DULY AUTHORIZED TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH A SERVICE PROVIDER FOR THE BALAY SILANGAN TO RENDER SERVICES, OR IS THE PREVIOUS MEMORANDUM OF AGREEMENT ENTERED INTO BY THE PROVINCIAL GOVERNMENT OF THIS PROVINCE, REPRESENTED BY FORMER GOVERNOR NELSON L. WHEREAS, the Provincial Government had previously entered into a Memorandum of Agreement (MOA), duly represented by Former Governor Nelson L. Dayanghirang, with the JJ Valderama Behavioral Management Center (JJVBMC), as its Service Provider which provided rehabilitation and treatment services to the patients catered at Balay Silangan Reformation Center, thru SP Resolution No. 15-652-03-2019, dated March 6, 2019;
