

MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), REPRESENTED BY ITS EXECUTIVE DIRECTOR III, MR. NESTOR D. DOMENDEN, CESO IV, RELATIVE TO THE IMPLEMENTATION OF AGRICULTURE AND FISHERY COUNCILS (AFCs) PROGRAMS/PROJECTS AND ACTIVITIES AT THE PROVINCIAL LEVEL WITH AN ALLOTTED AMOUNT OF TWO HUNDRED FOUR THOUSAND (P 204,000.00) PESOS.
