THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 03-2022 of the Municipality of Cateel, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. Re-appropriating the amount of P7,500,000.00 under the CY 2022 20% Development Fund shall be in accordance with the approved CY 2022 Supplemental Annual Investment Program (SAIP) / Development Plan, pursuant to Sections 287 and 305(i) of RA 7160; DILG MC No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF JMC No. 1, series of 2016, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. It is understood that the projects in the Supplemental AIP are likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in a Resolution Form;
- 2. The implementation for Collective Negotiation Agreement (CNA) in the amount of P 3,200,000.00 shall be in accordance with the Budget Circular No. 2022-3, dated October 19, 2022;
- 3. Fund implementation of Bayanihan Grant to Cities and Municipalities (BGCM) shall conform to LBC No. 125, dated April 7, 2020.

RESOLVED FURTHER, to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.
