**WHEREAS**, SB Resolution No. 2022-187, entitled: “AMENDING/REVISING THE PURPOSE OF THE LGU’S PROPOSED LOAN TO P40,000,000.00 FOR THE ACQUISITION OF LOT AND P110,000,000.00 FOR THE PURCHASE OF HEAVY EQUIPMENT AND LIGHT VEHICLES OF THIS MUNICIPALITY”, was passed and approved by the Sangguniang Bayan on September 26, 2022;

**WHEREAS**, SB Resolution No. 2022-200, entitled: "*AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL REPRESENTED BY ITS LOCAL CHIEF EXECUTIVE, HON. LEMUEL IAN M. LARCIA, TO THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION (P150,000,000.00) PESOS TO FINANCE THE ACQUISITION OF HEAVY EQUIPMENT, USABLE LETTER OF CREDIT (LC), AND LOT ACQUISITION PROJECTS INCLUDED IN THE LGU'S LOCAL DEVELOPMENT INVESTMENT PLAN (LIDP), AND TO GIVE FULL AUTHORITY TO THE LCE TO ASSIGN 20% OF THE LGU'S NATIONAL TAX ALLOTMENT AS SECURITY TO THE LOAN*", was passed and approved by the Sangguniang Bayan on October 17, 2022.




