Supplemental Budget No. 04, involving an appropriation of Ten Million Six Hundred Ninety-Three Thousand Five Hundred Forty-Nine Pesos (P10,693,549.00), was submitted to this Sanggunian for review on January 26, 2023, and the same was docketed as Communication No. 17-305-2023;

WHEREAS, the foregoing Appropriation Ordinances were submitted to the Sanggunian for review on January 26, 2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on April 26, 2023;


