A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NO. 03, SERIES OR 2023, ISSUED BY THE HONORABLE MICHELLE N. RABAT, CITY MAYOR OF MATI, DAVAO ORIENTAL, RE: “PRESCRIBING GUIDELINES FOR THE OPERATION OF A NIGHT MARKET ADJACENT TO THE MAYOR FRANCISCO G. RABAT PARK AND BAYWALK UNTIL DECEMBER 31, 2023”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF REPUBLIC ACT NO. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.




