A RESOLUTION RETURNING TO THE SANGGUNIANG BAYAN OF TARRAGONA, PROVINCE OF DAVAO ORIENTAL, MUNICIPAL ORDINANCE NO. 01, SERIES OF 2022, ENTITLED: "AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF THE LOCAL GOVERNMENT UNIT OF TARRAGONA, DAVAO ORIENTAL, REGULATING ITS USE AND PROVIDING PENALTY FOR VIOLATIONS THEREOF", WITH NO ACTION, CONSIDERING THAT THE CITED LEGAL BASIS IS INCONSISTENT WITH THE PROVISIONS OF RA 7160.

WHEREAS, Ms. Irene D. Tinong, Secretary to the Sangguniang Bayan of Tarragona, Davao Oriental, submitted Municipal Ordinance No. 01, series of 2022, for review and appropriate action of the Sangguniang Panlalawigan;

WHEREAS, Municipal Ordinance No. 01, series of 2022, was enacted by the Sangguniang Bayan on October 11, 2022 and was approved by the Municipal Mayor, Honorable Samuel L. Uy, on October 18, 2022;

WHEREAS, the ordinance was enacted to adopt the official seal for the Office of the Sangguniang Bayan of Tarragona as a symbol of its authority and constant reminder of the duties and responsibilities of its officials and employees;

WHEREAS, the first premise cited under Republic Act 7160 or the Local Code of 1991 is not in consonance with the composition of the Sangguniang Bayan, specifically:

SECTION. 457. Composition. – (a) The Sangguniang Panlungsod, the legislative body of the city, shall be composed of the city vice-mayor as presiding officer, the regular sanggunian members, the president of the city chapter of the liga ng mga Barangay, the president of the panlungsod na pederasyon ng mga Sangguniang Kabataan, and the sectoral representatives, as members.

WHEREAS, Section 446 of the same code provides for the composition of the Sangguniang Bayan, which states that: "The sangguniang bayan, the legislative body of the municipality, shall be composed of the municipal vice mayor as the presiding officer, the regular sanggunian members, the president of the municipal chapter of the liga ng mga barangay, the president of the pambayang pederasyon ng mga sangguniang kabataan, and the sectoral representatives, as members.";

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Shella Marie S. Go, Harold A. Montes, Daud V. Linsag, and Marietta D. Palmera, it was

RESOLVED, as it is hereby resolved, RETURNING TO THE SANGGUNIANG BAYAN OF TARRAGONA, PROVINCE OF DAVAO ORIENTAL, MUNICIPAL ORDINANCE NO. 01, SERIES OF 2022, ENTITLED: "AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF THE LOCAL GOVERNMENT UNIT OF TARRAGONA, DAVAO ORIENTAL, REGULATING ITS USE AND PROVIDING PENALTY FOR VIOLATIONS THEREOF", WITH NO ACTION, CONSIDERING THAT THE CITED LEGAL BASIS IS INCONSISTENT WITH THE PROVISIONS OF RA 7160:
