WHEREAS, Appropriation Ordinance No. 2022-05 of the Municipality of Banaybanay, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an appropriation of **Two Hundred Fifty Million Five Hundred Forty Thousand Seven Hundred Seventy Pesos (P250,540,770.00) and Six Million Five Hundred Fifty Thousand Pesos (P6,550,000.00)** for the FY 2023 Economic Enterprise and Public Utilities. The same was submitted to this Sanggunian for review on February 3, 2023, and was docketed as Communication No. 17-310-2023;




