WHEREAS, Appropriation Ordinance No. 2022-05 of the Municipality of Banaybanay, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an appropriation of Two Hundred Fifty Million Five Hundred Seventy Pesos (P250,540,770.00) and Six Million Five Hundred Fifty Thousand Pesos (P6,550,000.00) for the FY 2023 Economic Enterprise and Public Utilities. The same was submitted to this Sanggunian for review on February 3, 2023, and was docketed as Communication No. 17-310-2023;
