

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2022-04 OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

## THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

It is understood that the PPAs in the Supplemental AIP in this budget were likewise deliberated and favorably endorsed by the Municipal Development Council to Sangguniang Bayan for their approval in a Resolution Form, a copy of the aforesaid resolution shall be shall be attached as supporting document of this budget.

**RESOLVED FURTHER,** to inform the Municipality of Banaybanay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Banaybanay, Davao Oriental, through the Municipal Mayor.
