A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05-2022 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 05-2022 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 4, involving an appropriation of Twenty One Million Seven Hundred Four Thousand Three Hundred Seventeen Pesos & 75/100 (P21,704,317.75), was submitted to the Sanggunian for review on December 14, 2022, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 05-2022 of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY,** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The grant of Collective Negotiation Agreement (CNA) shall be in accordance with DBM BC No. 2022-3, dated October 19, 2022;
- 2. The lump sum appropriations in Other Supplies and Materials Expenses/Other MOOE/General Service, etc. shall be subject to Sections 305(b) and 335 of RA 7160; RA 9184 (Government Procurement Reform Act) and its revised IRR; and other existing pertinent laws, rules and regulations imposing restraints on government expenditures;

RESOLVED FURTHER, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.
