**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 15-03-01-2023 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 13-02-11-2016 DATED NOVEMBER 21, 2016, OTHERWISE KNOWN AS THE “REGISTRATION ORDINANCE OF FISHING BANCA, THREE (3) GROSS TONNAGE AND BELOW” OF THIS SANGGUNIANG BAYAN PARTICULARLY IN SECTION 7 THEREOF BY ADDING “FISHING VESSEL CLEARANCE CERTIFICATE (FVCC) ISSUED BY THE PNP MARITIME GROUP” AS THE NUMBER 10 REQUIREMENT FOR REGISTRATION”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.**

**WHEREAS**, Section 5.3 of the Implementing Guidelines of Executive Order 305, dated April 2, 2004, issued by the President of the Philippines provides that: “*the LGUs shall require the applicant to secure a clearance from the PNP Maritime Office in the LGU or in its absence, the local PNP, certifying that the fishing vessel is not involved in any criminal offense*”;

**WHEREAS**, submitted for review of this August Body is Municipal Ordinance No. 15-03-01-2023, which was enacted by the Sangguniang Bayan of Boston, Davao Oriental, on January 23, 2023 in adherence to the provisions prescribed in Section 5.3 of the Implementing Guidelines of Executive Order No. 305, dated April 2, 2004, issued by the President of the Philippines;


