

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 92, SERIES OF 2022, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 92, series of 2022, of the Municipality of Boston, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 4, involving an appropriation of Seventeen Million Three Hundred Fifty-Six Thousand Three Hundred Seventy-Five Pesos & 10/100 (P17,356,375.10), was submitted to the Sanggunian for review on December 28, 2022, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

RESOLVED, to declare Appropriation Ordinance No. 92, series of 2022, of the Municipality of Boston, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Reappropriation in the amount of P8,179,689.89 under the CY 2022 Development Fund shall be in accordance with the approved CY 2022 Supplemental Annual Investment Program (SAIP) Development Fund pursuant to Sections 287 and 305(i) of R.A. 7160, DILG Memorandum Circular (MC) No. 2004-130, dated October 1, 2004; and DILG-NEDA-DBM-DOF-JMC No. 2017-1, dated February 22, 2017. It is understood that the projects in the Supplemental AIP are likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in a Resolution form.

RESOLVED FURTHER, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.
