A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05-2022 OF THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 05-2022 of the Municipality of Cateel, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 04, involving an appropriation of **Three Million Five Hundred Twenty Thousand Pesos (P3,520,000.00)**, was submitted to the Sanggunian for review on January 5, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 05-2022 of the Municipality of Cateel, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. The grant of Service Recognition Incentive (SRI) for Government Employees for Fiscal Year 2022 shall be in accordance with Budget Circular No. 2022-4, dated December 20, 2022.
2. The grant of the one-time Gratuity Pay not exceeding Five Thousand Pesos (P5,000.00) for each qualified worker for FY 2022 shall be in accordance with Budget Circular No. 2022-5, dated December 28, 2022.

RESOLVED FURTHER, to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

MOREOVER, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016 in relation to Sections 56(a) and 327 of RA 7160, and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "*Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review.*"

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.


