A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2022-06 OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 2022-06 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 05, involving an appropriation of **Five Million Nine Hundred Fifty-Eight Thousand Seven Hundred Fifteen Pesos & 90/100 (P5,958,715.90)**, was submitted to the Sanggunian for review on January 6, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-06 of the Municipality of Banaybanay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Fund appropriation intended for payment of Service Recognition Incentive (SRI) to its officials and employees in the amount of P1,860,000.00 shall be in accordance with DBM Budget Circular No.2022-4, dated December 20, 2022.
2. Fund Utilization under Miscellaneous Personal Benefits Fund (MPBF) shall be covered with specific guidelines issued by the Department of Budget and Management or other authorized government agency.

RESOLVED FURTHER, to inform the Municipality of Banaybanay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

MOREOVER, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016 in relation to Sections 56(a) and 327 of RA 7160, and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, *“Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review.”*

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Banaybanay, Davao Oriental, through the Municipal Mayor.




