WHEREAS, Appropriation Ordinance No. 01, series of 2022, of the Municipality of Tarragona, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 1, involving an appropriation of <u>Eight Million Three Hundred Ninety-Two Thousand Eighty-Eight Pesos & 19/100 (P8,392,088.19)</u>, was submitted to this Sanggunian for review on January 23, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 01, series of 2022, of the Municipality of Tarragona, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the appropriations in the amount of P1,500,000.00 intended for the procurement of Logistic Vehicle / Capital Outlay under the Office of the Mayor shall be subject to Sections 305(b) and 335 of RA 9184 (Government Procurement Reform Act) and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures. Likewise, purchase of Motor Vehicles (MV) shall conform with the guidelines prescribed under the following:

- i) NBC Nos. 446 and 446-A, dated November 24, 1995 and January 30, 1998, respectively;
- ii) Budget Circular No. 2017-1 and 2010-2, dated April 26, 2017 and March 1, 2010, respectively;
- iii) Administrative Order No. 233, dated August 1, 2008 as amended by Administrative Order No. 15, dated May 25, 2011, and Administrative Order No. 14, s. 2018;
- iv) Budget Circular 2019-2, dated March 4, 2019 and Budget Circular 2019-9, dated May 6, 2019;
- v) Circular Letter 2019-9, dated July 11, 2019, and other related ensuing issuances regarding the purchase of MV and purchase of plane ticket pursuant to GPPB Resolution No. 11-2017, dated March 10, 2017;
- vi) The LGU is also reminded that an Authority to Purchase of MV is condition precedent before an Invitation to Bid is posted;

RESOLVED FURTHER, to inform the Municipality of Tarragona, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Tarragona, Davao Oriental, through the Municipal Mayor.
