A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCES OF VARIOUS LOCAL GOVERNMENT UNITS OF THIS PROVINCE TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 09, series of 2022, of the City of Mati, Davao Oriental, authorizing its FY 2022 General Fund Supplemental Budget No. 08, involving an appropriation of **One Hundred Twenty-Two Million Six Hundred Thousand Six Hundred Two Pesos & 27/100 (P122,600,602.27)**. The same was re-submitted to this Sanggunian for review on March 1, 2023, and was docketed as Communication No. 17-285-2023;

WHEREAS, Appropriation Ordinance No. 01-02-02-2023 of the Municipality of Cateel, Davao Oriental, authorizing its FY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of **Twenty-Five Million Six Hundred Thirty-Four Thousand Eight Hundred Twenty Pesos & 31/100 (P25,634,820.31)**. The same was

submitted to this Sanggunian for review on February 9, 2023, and was docketed as Communication No. 17-320-2023;

WHEREAS, Appropriation Ordinance No. 04, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an appropriation of Two Hundred Ninety-Three Million Seven Hundred Sixty Thousand Five Hundred Nineteen Pesos (P293,760,519.00); and Appropriation Ordinance No. 05, series of 2022 for the Local Economic Enterprise (GGCAST Operations) of the said municipality for CY 2023 amounting to Twenty-Seven Million Seven Hundred Thirty Thousand Six Hundred Thirty-Four Pesos (P27,730,634.00). The same were submitted to this Sanggunian for review on February 9, 2023, and docketed as Communication No. 17-322-2023;

WHEREAS, submitted for review on February 15, 2023 from the Municipality of Baganga, are the following:

- Appropriation Ordinance No. 01, series of 2022 authorizing the FY 2022 General Fund Supplemental Budget No. 01, involving an appropriation of Eighty-Two Million Seven Hundred Twenty-Eight Thousand Eight Hundred Seventeen Pesos & 68/100 (P82,728,817.68). The same was docketed as Communication No. 17-325-2023;
- Appropriation Ordinance No. 02, series of 2022 authorizing the FY 2022 General Fund Supplemental Budget No. 02, involving an appropriation of Nineteen Million Three Hundred Thousand Three Hundred Sixty-Seven Pesos & 41/100 (P19,300,367.41). The same was docketed as Communication No. 17-326-2023;
- Appropriation Ordinance No. 04, series of 2022 authorizing the FY 2023 General Fund Annual Budget, involving an appropriation of Four Hundred Nineteen Million Five Hundred Forty-One Thousand Two Hundred Sixty-Eight Pesos & 43/100 (P419,541,268.43). The same was docketed as Communication No. 17-332-2023;
- Appropriation Ordinance No. 05, series of 2022 authorizing the FY 2022 General Fund Supplemental Budget No. 03, involving an appropriation of Six Million Three Hundred Ninety-Seven Thousand Two Hundred Seventy-Five Pesos & 31/100 (P6,397,275.31). The same was docketed as Communication No. 17-333-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on May 10 - May 30, 2023, respectively;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;


