**WHEREAS**, the subject Municipal Ordinance No. 304-17-2023 was enacted by the Sangguniang Bayan on January 24, 2023;

**WHEREAS**, Section 12(b) of the Republic Act 10121 also known as “*Philippine Disaster Risk Reduction and Management Act of 2010*” states that, “xxx. The LDRRMOs shall be initially organized and composed of a DRRMO to be assisted by three (3) staff responsible for: (1) administration and training; (2) research and planning; and (3) operations and warning. Xxx”;


