MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DAVAO REGIONAL MEDICAL CENTER (DRMC), REPRESENTED BY ITS MEDICAL CENTER CHIEF, DR. BRYAN O. DALID, RELATIVE TO THE PROVINCEWIDE HEALTH CARE DELIVERY SYSTEM FOR DRMC AS APEX OR END-REFERRAL HOSPITAL.

WHEREAS, presented for consideration before the August Body is an urgent request of the Honorable Governor Corazon N. Malanyaon, thru her letter, dated March 13, 2023, addressed to the Honorable Members of the 17th Sangguniang Panlalawigan thru the Vice Governor, Honorable Niño Sotero L. Uy, Jr., for the passage of a resolution authorizing her for the aforementioned subject matter, docketed as Communication No. 17-354-2023;

WHEREAS, the Province of Davao Oriental intends to build a provincewide healthcare delivery system that offers quality and accessible healthcare products and

services and shall be linked to at least one (1) apex or end-referral hospital in line with the Universal Health Care Act or the RA 11233;

WHEREAS, the Davao Regional Medical Center, a level three teaching and training hospital is willing to be an apex/end-referral hospital in Davao Region of the health care delivery system of the Province;

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states among others that: *“the Provincial Governor, as the chief executive of the provincial government, shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance”*;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Daud V. Linsag, Rotchie M. Ravelo, Harold A. Montes, and Art Benjie C. Bulaong, it was


