A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 528, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE AMENDING BY INSERTION/ADDITION OF PROVISIONS UNDER CITY ORDINANCE NO. 459, SERIES OF 2021 BY PROVIDING CITY PROPER AND LUBAN, LANCA, CABUAYA ROUTES", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF REPUBLIC ACT 7160.

**WHEREAS**, Section 16 of the Local Government Code of 1991, provides that: "Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx;

WHEREAS, submitted for review before the August Body is City Ordinance No. 528, series of 2023, of the Sangguniang Panlungsod of Mati, Davao Oriental, docketed as Communication No. 17-329-2023;
