A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 529, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE AMENDING CITY ORDINANCE NO. 315, SERIES OF 2018, OTHERWISE KNOWN AS AN ORDINANCE REVISING THE FARE RATE OF TRICYCAB-FOR-HIRE (BAOBAO) SOLICITING PASSENGERS WITHIN THE CITY OF MATI, PROVINCE OF DAVAO ORIENTAL", SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Section 16 of the Local Government Code of 1991, provides that: "Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx;
