WHEREAS, Ms. Romilda A. Marquez, Secretary to the Sangguniang Bayan of Cateel, Davao Oriental, in her letter, dated March 8, 2023, submitted Municipal Ordinance No. 01-27-02-2023 for legislative review of the Sangguniang Panlalawigan;

prohibited from performing child delivery procedures within the territorial jurisdiction of the Municipality of Cateel;

WHEREAS, Municipal Mayor Emilou C. Nuñez approved the said Municipal Ordinance on March 8, 2023, which was enacted by the 11th Sangguniang Bayan of Cateel on its 28th Regular Session held last February 27, 2023;


