A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 93. SERIES OF 2022, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 93, series of 2022, of the Municipality of Boston, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an appropriation of One Hundred Seventy Million Seven Hundred Fifty-Nine Thousand Five Hundred Four Pesos (P170,759,504.00), was submitted to this Sanggunian for review on December 28, 2022, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

# THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 93, series of 2022, of the Municipality of Boston, Davao Oriental, OPERATIVE IN ITS ENTIRETY as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The LGU is advised to make necessary adjustment by way of reducing the appropriation by P231,276.00 since the reduction of NTA would affect the implementation of PPAs identified under 20% Development Fund, 5% Confidential Fund and possibly on other items;
- 2. Reiterating the previous recommendation that the LGU shall adapt measure by way of partially implementing salary compensation, also the no filling-up of vacant funded positions except for mandatory one, in order to reduce the aforesaid excess in the amount equivalent to that which is within the exact 45% Personal Services (PS) limitation, pursuant to DBM LBC No. 145, dated March 2, 2022;

RESOLVED FURTHER, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.
