A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 06. SERIES OF 2022, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 06, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 4, involving an appropriation of Ten Million Six Hundred Ninety-Three Thousand Four Hundred Fifty-Nine Pesos (P10,693,459.00), was submitted to this Sanggunian for review on January 26, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 06, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- The grant of Service Recognition Incentive (SRI) for government employees for Fiscal Year 2022 shall be in accordance with Budget Circular No. 2022-4, dated December 20, 2022;
- 2. The grant of one-time Gratuity Pay not exceeding Five Thousand Pesos (P5,000.00) for each qualified worker for Fiscal Year 2022 shall be in accordance with Budget Circular No. 2022-5, dated December 28, 2022;

RESOLVED FURTHER, to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

MOREOVER, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, which requires that within three (3) days after the approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary of the Sanggunian shall forward the said ordinance to the Sangguniang Panlalawigan for review.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.
