A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-01 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE RENAMING SAN VICENTE ELEMENTARY SCHOOL INTO LUIS BUCTUANON ELEMENTARY SCHOOL” IN BARANGAY SAN VICENTE, BANAYBANAY, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, the Sangguniang Panlalawigan is mandated to *review all ordinances approved by the Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the mayor*, pursuant to Article III, Section 468(a)(1)(i) of Republic Act 7160;

WHEREAS, Chapter II, Section 13(e) of Republic Act 7160 empowers the Sangguniang Bayan to change the name of Municipal Public Secondary / Elementary

Schools within its territorial jurisdiction upon the recommendation of the Local School Board concerned;

WHEREAS, presented for review before the August Body is Municipal Ordinance No. 2023-01 of the Sangguniang Bayan of Banaybanay, Davao Oriental, docketed as Communication No. 17-343-2023;

WHEREAS, the National Historical Commission of the Philippines (NHCP) interposes no objection on the foregoing based on the thorough deliberations of the Sangguniang Bayan of Banaybanay and the Local School Board concerned. However, it is recommended that the old name of the school be placed beneath the new name as quoted on the second paragraph of their letter, dated March 22, 2022, signed by the Chairman, Dr. Rene R. Escalante;




