A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 09-17-2022 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 09-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2023 General Fund Annual Budget, involving an appropriation of **One Hundred Seventy-Nine Million Four Hundred Twenty-Two Thousand Seven Hundred Seventy-Two Pesos (P179,422,772.00)**, was submitted to this Sanggunian for review on January 11, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 09-17-2022 of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. The LGU is advised to make necessary adjustment by way of reducing the appropriation by P111,267.00 since the reduction of NTA would affect the implementation of PPAs identified under 20% Development Fund, 5% Confidential Fund and possibly on other items;
2. The excess in the amount of P878.80 under the 2% Discretionary Fund should be reverted to Unappropriated Balance of the General Fund;

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

MOREOVER, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 112, dated June 10, 2016, which requires that *“Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.”*

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.


