A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCE NO. 01-2023 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 01-2023 of the Municipality of Lupon, Davao Oriental, authorizing its FY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of <u>Eighteen Million Three Hundred Fifty-Six Thousand Seven Hundred Fifty-One Pesos (P18,356,751.00).</u> The same was submitted to this Sanggunian for review on March 30, 2023, and was docketed as Communication No. 17-367-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing
