**A RESOLUTION RETURNING TO THE LOCAL CHIEF EXECUTIVE THROUGH THE PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE, THE HEREIN LETTER DOCKETED AS COMMUNICATION NO. 17-375-2023, SPECIFICALLY THE REQUEST FOR THE RETITLING OF POSITION FROM NUTRITION OFFICER I (ITEM NO. 19, SG 10) TO ADMINISTRATIVE ASSISTANT IV (BOOKBINDER IV) (SG 10) UNDER THE PROVINCIAL TOURISM OFFICE, THIS PROVINCE, TOGETHER WITH THE FINDINGS OF THE SP COMMITTEE ON LABOR, EMPLOYMENT, CIVIL SERVICE & HUMAN RESOURCE DEVELOPMENT, FOR FURTHER REVIEW AND FOR WHATEVER ACTION DEEMED APPROPRIATE THEREON.**

**WHEREAS**, the Honorable Governor Corazon N. Malanyaon, in her letter, dated April 4, 2023, requested this August Body for an appropriate legislative action relative to the abolition, creation and retitling/renaming of various plantilla positions. Docketed as Communication No. 17-375-2023, it was referred to the Committee on Labor, Employment, Civil Service & Human Resource Development, for appropriate action;

**WHEREAS**, upon review, the said Committee finds the request for the retitling/renaming of **Nutrition Officer I (Item No. 19, SG 10)** to **Administrative Assistant IV (Bookbinder IV) SG 10** under the Provincial Tourism Office, this Province, not consistent with the existing rules relative thereto;

**WHEREAS**, as stated in DBM LBC No. 137-2021 (IOS-LGU 2021), the old position title **Nutrition Officer I** falls under the Medicine and Health Services occupational group. On the other hand, the new position title **Administrative Assistant IV (Bookbinder I)** belongs to Administrative Services group, as defined in DBM BC 2004-03, dated March 6, 2004;

**WHEREAS**, pursuant to Item 4.1 (Reclassification) of DBM Budget Circular No. 2018-3, dated July 30, 2018, old position title can be retitled, provided that the new position title belongs to the same occupational group;

**WHEREAS**, reclassification shall not apply to vacant regular positions which necessitate changes in their position titles for being under any instances cited in Item 4.2 of the same Circular. Instead, the conversion of positions shall be effected, i.e., the items shall be abolished, and in their stead, the appropriate positions shall be created;

**WHEREAS**, the Committee finds the need to return the letter request to the Local Chief Executive for their further review and appropriate action thereon;

**WHEREFORE**, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Rotchie M. Ravelo, Harold A. Montes, Stephen Paul L. Uy, Shella Marie S. Go, Rustan R. Castillones, Anna Cheryl N. Castro, and Andy A. Monday, it was


