A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 04, SERIES OF 2022, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 04, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2023 General Fund Annual Budget, involving an appropriation of Two Hundred Ninety-Three Million Seven Hundred Sixty Thousand Five Hundred Nineteen Pesos (P293,760,519.00), was submitted to this Sanggunian for review on February 9, 2023, pursuant to the provisions of Republic Act No. 7160;

RESOLVED, to declare Appropriation Ordinance No. 04, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and further advising the LGU to make necessary adjustment by way of reducing the appropriation by P132,397.00 since the reduction of NTA would affect the implementation of PPAs identified under 20% DF, 5% CF and possibly on other items.

RESOLVED FURTHER, to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.
