A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05, SERIES OF 2022, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 05, series of 2022, of the Municipality of Baganga, Davao Oriental, authorizing its FY 2022 General Fund Supplemental Budget No. 03, involving an appropriation of Six Million Three Hundred Ninety-Seven Thousand Two Hundred Seventy-Five Pesos & 31/100 (P6,397,275.31), was submitted to this Sanggunian for review on February 21, 2023, pursuant to the provisions of Republic Act No. 7160;

MOREOVER, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 112, dated June 10, 2016, which requires that "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review."

**RESOLVED FURTHER,** to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.
