A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCES OF THE MUNICIPALITIES OF BANAYBANAY AND GOVERNOR GENEROSO, AND THE CITY OF MATI, ALL OF THIS PROVINCE, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 2023-01 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of <u>Twelve Million Three Hundred Thousand (P12,300,000.00) Pesos.</u> The same was submitted to this Sanggunian for review on April 18, 2023, and was docketed as Communication No. 17-383-2023;

WHEREAS, Appropriation Ordinance No. 01, series of 2023, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of <u>Fourteen Million Seven Hundred Fifty-Five Thousand Four Hundred Twelve Pesos & 1/100 (P14,755,412.01).</u> The same was submitted to this Sanggunian for review on April 18, 2023, and was docketed as Communication No. 17-384-2023;

WHEREAS, Appropriation Ordinance No. 01, series of 2023, of City of Mati, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of Ninety-Two Million Five Hundred Ninety-One Thousand Four Hundred Twenty-Nine Pesos & 69/100 (P92,591,429.69). The same was submitted to this Sanggunian for review on April 19, 2023, and was docketed as Communication No. 17-385-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

**WHEREAS,** the reglementary period of review of the foregoing Appropriation Ordinances will end on July 18, 2023;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Harold A. Montes, Andy A. Monday, Stephen Paul L. Uy, Rustan R. Castillones, and Anna Cheryl N. Castro, it was
