**WHEREAS**, ETRACS is an Information System intended to automate the real property tax administration and local revenue collection and presently running in the Treasury and Assessment Offices of the PLGU Davao Oriental, developed and maintained by Rameses Systems Inc;

**WHEREAS**, using ETRACS will address the current challenges confronting the Province's treasury and assessment operations, particularly the lack of System Interoperability between the PLGU and its component Municipalities due to the diversity of information systems currently installed, as well as the lack of a system for RPT Administration and Revenue Collection in some LGUs, among other things;

**WHEREAS**, the Provincial Government will procure and turn-over to the MLGU of Banaybanay all hardware, equipment, computers, devices, cables, and other materials to be used in the installation and implementation of ETRACS in the respective Treasurer and Assessor's Office of the said municipality;
