A RESOLUTION INFORMING THE HONORABLE MAYOR ROWELL F. ROSIT OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, THAT THIS SANGGUNIANG PANLALAWIGAN HAS ALREADY CONFIRMED AND DECLARED OPERATIVE THE CY 2023 ANNUAL BUDGET OF THE LGU OF BOSTON, TOGETHER WITH ITS ANNUAL INVESTMENT PROGRAM, AND THE SAME WERE PROPERLY RETURNED TO THE CONCERNED LOCAL GOVERNMENT UNIT ON APRIL 4, 2023.

WHEREAS, the Honorable Mayor Rowell F. Rosit, in his letter, dated April 26, 2023, requested this Sangguniang Panlalawigan to allow them to retrieve the copies of CY 2023 Annual Investment Program and Annual Budget of the LGU of Boston, for correction;

WHEREAS, the said request for retrieval of copies was to correct some clerical errors thereof;

WHEREAS, the CY 2023 Annual Budget, together with its Annual Investment Program, was submitted to the Sangguniang Panlalawigan on December 27, 2022. It was duly confirmed and declared operative thru SP Resolution No. 17-381-03-2023, dated March 15, 2023, and the official documents were properly returned to the LGU on April 4, 2023;

WHEREAS, the Sangguniang Panlalawigan has exercised its review and approval functions on the aforementioned documents in accordance with Section 468 of RA 7160. Given that the said official documents were properly returned to the Municipality of Boston, the Sangguniang Panlalawigan Support Services Office has retained a copy of the same for purposes of maintaining an official file/record as the custodian of such documents, in accordance with Section 469 of RA 7160. Therefore, there is only one official file remaining in the said office.

WHEREAS, Section 106 of the Local Government Code provides for the creation of a Local Development Council (LDC) in every LGU and its functions to assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, Section 109(a)(2) of the same Code also provides for the functions of the municipal development council, among other things, to formulate the medium-term and annual public investment programs. Accordingly, the power to formulate Annual Investment Programs belongs to the development council. Hence, any corrections or changes thereof, the Municipal Development Council also has the power to amend the same;

WHEREAS, thereafter, the Municipal Development Council has to submit the same to the Sangguniang Bayan for its review and approval pursuant to Section 109(a) and Section 114 of the said Code;

WHEREAS, the Sangguniang Panlalawigan may be furnished a copy of approved amended resolution/ordinance for their information and/or appropriate action;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Harold A. Montes, Andy A. Monday, Stephen Paul L. Uy, Rustan R. Castellones, and Anna Cheryl N. Castro, it was

RESOLVED, as it is hereby resolved, **INFORMING THE HONORABLE MAYOR ROWELL F. ROSIT OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, THAT THIS SANGGUNIANG PANLALAWIGAN HAS ALREADY CONFIRMED AND DECLARED OPERATIVE THE CY 2023 ANNUAL BUDGET OF THE LGU OF BOSTON, TOGETHER WITH ITS ANNUAL INVESTMENT PROGRAM, AND THE SAME WERE PROPERLY RETURNED TO THE CONCERNED LOCAL GOVERNMENT UNIT ON APRIL 4, 2023;**


