A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 03-06-03-2023 OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, ENTITLED: “IMPLEMENTING THE ZERO OPEN DEFECATION (ZOD) IN ALL BARANGAYS AND IMPOSING FINES AND PENALTIES FOR VIOLATIONS THEREOF, ESTABLISHING THE ZOD VERIFICATION AND CERTIFICATION TEAM, AND APPROPRIATING FUNDS FOR THE PURPOSE”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, Ms. Romilda A. Marquez, Secretary to the Sangguniang Bayan of Cateel, Davao Oriental, in her letter, dated April 12, 2023, submitted Municipal Ordinance No. 03-06-03-2023, for legislative review of the Sangguniang Panlalawigan;

WHEREAS, the said Ordinance requires every household within the territorial jurisdiction of the Municipality of Cateel to have a sanitary toilet in their respective homes and ensure proper disposal of human waste in order to prevent the occurrence of diseases caused by an open defecation;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Harold A. Montes, Marietta D. Palmera, and Anna Cheryl N. Castro, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 03-06-03-2023 OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, ENTITLED: "IMPLEMENTING THE ZERO OPEN DEFECATION (ZOD) IN ALL BARANGAYS AND IMPOSING FINES AND PENALTIES FOR VIOLATIONS THEREOF, ESTABLISHING THE ZOD VERIFICATION AND CERTIFICATION TEAM, AND APPROPRIATING FUNDS FOR THE PURPOSE"**, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160;




