

A RESOLUTION GRANTING ACCREDITATION TO DAVAO ORIENTAL FORMER REBELS ASSOCIATION (DOFRA) BAGANGA CHAPTER, WITH OFFICE ADDRESS AT PUROK CENTRO, BARANGAY CAMPAWAN, MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, CONSIDERING THAT THE SAME HAS COMPLIED ALL THE REQUIREMENTS SET FORTH FOR ACCREDITATION, PURSUANT TO DILG MEMORANDUM CIRCULAR NO. 2022-083, DATED JUNE 15, 2022 AND PROVINCIAL ORDINANCE NO. 14-01-02-2014, AS AMENDED BY PROVINCIAL ORDINANCE NO. 17-01-08-2022.
