WHEREAS, Ms. Irene D. Tinong, Secretary to the Sangguniang Bayan of Tarragona, Davao Oriental, submitted Municipal Ordinance No. 05, series of 2023, for review and appropriate action of the Sangguniang Panlalawigan,

WHEREAS, Municipal Ordinance No. 5, series of 2023, otherwise known as the "Banning of Firecracker Ordinance of Tarragona, Davao Oriental", was enacted last April 17, 2023 and approved by the Honorable Municipal Mayor Samuel L. Uy on April 20, 2023;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Stephen Paul L. Uy, and Daud V. Linsag, it was
