**A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 560, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE TO PROHIBIT THE SALE, RENTAL, TRANSFER, DISTRIBUTION, MANUFACTURE, AND/OR PRODUCTION OF COUNTERFEIT AND ILLICIT FOOD, CIGARETTES, AND MEDICINES”, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.**

**WHEREAS**, Section 16 of Republic Act 7160, provides that: “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Xxx”;

**WHEREAS**, Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, in his letter, dated April 25, 2023, submitted City Ordinance No.

560, series of 2023, for review of the August Body, docketed as Communication No. 17-391-2023;

**WHEREAS**, the said Ordinance was enacted by the 7<sup>th</sup> Sangguniang Panlungsod of Mati, Davao Oriental last April 18, 2023, purposely to adhere with the policy of the National Government to curb the proliferation and introduction into commerce of pirated, counterfeit, or fake goods, articles and/or services, illicit tobacco products, and the commission of other acts that violate intellectual property rights and other laws of the Republic of the Philippines;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Eleuterio C. Manaytay, Stephen Paul L. Uy, Harold A. Montes, Marietta D. Palmera, and Art Benjie C. Bulaong, it was
