

A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-04 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE DECLARING EVERY THIRD WEEK OF JUNE OF EVERY YEAR AS BANAYAN FESTIVAL IN THE MUNICIPALITY OF BANAYBANAY, SHOWCASING THE TALENTS AND RICHNESS OF AN ANCIENT AND DYNAMIC CULTURES OF THE BANAYBANAYONS”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, Mr. Eden Celestino S. Cacho, Secretary to the Sangguniang Bayan of Banaybanay, Davao Oriental, in his letter, dated April 24, 2023, submitted Municipal Ordinance No. 2023-04 to the Sangguniang Panlalawigan for legislative review and appropriate action;

WHEREAS, the said ordinance declares every third week of June of every year as Banayan Festival of the Municipality of Banaybanay which includes June 21 as Araw ng Banaybanay;

WHEREAS, the said Local Government Unit endeavors to enhance creativity, collaboration skills, and strengthen the dynamic culture of Banaybanayons. This program will remind the young generations of the value and spirit that makes the Banaybanayons distinct as a community;

WHEREAS, Municipal Ordinance No. 2023-04 was enacted by the 16th Sangguniang Bayan of Banaybanay on its 35th Regular Session held on April 04, 2023 and was signed and approved by Mayor Lemuel Ian M. Larcia on April 18, 2023;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Eleuterio C. Manaytay, Rotchie M. Ravelo, and Marietta D. Palmera, it was




